The remote curriculum: what is taught to pupils at home

A pupil's first day of being educated remotely might look different from our standard approach, while we take all necessary actions to prepare for a longer period of remote teaching.

What should my child expect from immediate remote education on the first day or two of pupils being sent home?

Children should login to Google Classroom where learning activities will be set. If you are unable to login, please contact the office.

Following the first few days of remote education, will my child be taught broadly the same curriculum as they would if they were in school?

Yes - as much as possible. There will be some aspects, such as PE, that will look different. However, we will strive to ensure children at home are able to achieve the same as they can at school.

Remote teaching and study time each day

How long can I expect work set by the school to take my child each day?

We expect that remote education (including remote teaching and independent work) will take pupils broadly the following number of hours each day:

EYFS and Key Stage 1	3 hours
Key Stage 2	4 hours

This will be a mix of independent activities, live and pre-recorded lessons, and Google Meets. Year groups will provide examples of how best to break the work down into small manageable chunks for pupils.

Accessing remote education

How will my child access any online remote education you are providing?

EYFS	Tapestry will be used. All work will be explained, set, and handed in through this system.
Key Stage 1	Work will be set through year group pages on the school website and videos available

Key Stage 2	This is through Google Classroom, including Google Meet. All work will be explained, set, and handed in through this system. For those pupils who aren't accessing google classroom then the work will be available through year group pages on the school website and videos available

If my child does not have digital or online access at home, how will you support them to access remote education?

We recognise that some pupils may not have suitable online access at home. We take the following approaches to support those pupils to access remote education:

- Providing technology at home, including devices and internet access, where possible
- Providing paper-based resources, although this is our last resort and least preferable

How will my child be taught remotely?

We use a combination of the following approaches to teach pupils remotely:

- Pre-recorded lessons
- Lessons provided through PowerPoints
- Drop-in sessions provided by the teacher and/or LSAs
- Live lessons

Engagement and feedback

What are your expectations for my child's engagement and the support that we as parents and carers should provide at home?

We expect that children complete the work set on a daily basis. We understand that it may be challenging depending on home circumstances (siblings, limited technology, working parents etc). We know that work may be submitted later too, and we will endeavour to mark all work sent in. Through use of recorded live lessons and recorded videos, we aim to ensure children will not miss out, and can catch-up at a later time.

How will you check whether my child is engaging with their work and how will I be informed if there are concerns?

We will monitor who is completing the work through Tapestry (EYFS), work sent to the teacher (KS1) and the hand-in system on Google Classroom (KS2). We will also be in touch if learning is not being submitted to see if we can help in any way. Each teacher has a work email account that parents can also raise their concerns if their child is struggling during the day with the work set. Teachers and LSAs will endeavour to answer any questions or concerns raised by parents within a timely manner.

How will you assess my child's work and progress?

Feedback can take many forms and may not always mean extensive written comments for individual children. For example, whole-class feedback or quizzes marked automatically via digital platforms are also valid and effective methods, amongst many others. Our approach to feeding back on pupil work is as follows:

- Marking of work handed in. This may be done by a teacher or LSA, and will be appropriate to the work set
- Through direct comments and feedback within a Google Meet lesson
- Via a parent or carer, if necessary
- Where work is given on paper and collected from school, the work must be returned to the school for teachers to give feedback on, or alternatively it can be submitted via Google Classrooms (even though completed on paper)

Additional support for pupils with particular needs

How will you work with me to help my child who needs additional support from adults at home to access remote education?

We recognise that some pupils, for example some pupils with special educational needs and disabilities (SEND), may not be able to access remote education without support from adults at home. We acknowledge the difficulties this may place on families, and we will work with parents and carers to support those pupils in the following ways:

- Individual/small group support by a teacher or LSA through Google Meet
- Extra resources sent home to parents to scaffold their child's learning
- Differentiated work set on Tapestry (EYFS), via the school website (KS1 & 2), Google Classroom (KS2), or paper-based based on a child's needs and ability
- Consolidation work either set on Tapestry (EYFS), via the school website (KS1 & 2), Google Classroom (KS2), or paper-based to support a child's retention of new learning
- Regular email and telephone support by the teacher, SENCo or member of SLT to the parent

Remote education for self-isolating pupils

Where individual pupils need to self-isolate but the majority of their peer group remains in school, how remote education is provided will likely differ from the approach for whole groups. This is due to the challenges of teaching pupils both at home and in school. This will, however, be under constant review.

If my child is not in school because they are self-isolating, how will their remote education differ from the approaches described above?

Our remote education in these circumstances will not differ at these times from the provision detailed above. Children who are self-isolating will be able access the work via Tapestry (EYFS), via the school website (KS1 & 2), or Google Classroom (KS2).
